Members who have already cast their votes on resolutions by remote e-voting prior to meeting, will also be eligible to participate in the AGM through VC/OAVM but shall not be entitled to cast their vote on resolutions again.

Members who would like to express their views or ask questions during the AGM, may register themselves as a speaker upto September 22, 2025 by sending an email on companysecretary@shalby.in from their registered email address, mentioning their name, demat account number / folio number and mobile number.
