Hence Second Appeal had been field before the Gujarat Value Added Tax Tribunal for which the proceeding is still going on.	High court order received was not in our favour. We anticipate that we will get verdict in our favour on the basis of facts of the matter involved, analysis of the provisions of the law, available judicial precedents & basis our consultation with our legal advisor.
